- Should a child need to be absent from school for an extended period of time during the school year, parents will be responsible for tuition payments for the months missed.

All new students are required to complete testing prior to attending. **The following fees will be due with registration.**

New Preschool / Pre-K students will be tested in early August prior to the beginning of school	\$70
Continuing students going into Kindergarten in fall of 2024 will be tested in late May (includes 2 tests)	\$150
New Kindergarten students will be tested in late May 2024 (includes 3 tests)	\$195
New First – Sixth Grade students will be tested in late May 2024	\$175

State Tax Scholarships (STO) / Empowerment Scholarship Account (ESA)

*If you have enrolled your child in the Arizona State Tax Scholarship program or the Arizona Empowerment Scholarship program and will be expecting funds, please note:

- You are ultimately responsible for all tuition and fees associated with your child.
- A \$1,000 deposit per child is due in June, which is **NON-REFUNDABLE** if the child withdraws.
- The 9% yearly or 4% semester tuition discount does NOT apply to tuition paid with scholarship funds
